**Freedom of Information (FOI) request – Access Decision**

On 1 January 2020, the Department of Home Affairs (the Department) received a request for access to a document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following:

*The number of EOIs in the submitted status as of 31 December 2019 for the following sub classes for each occupation for subclass 189 categorised by their points claimed*

*Requested points are 75, 80, 85, 90 and 95+*

**2 Authority to make decision**
