**Freedom of Information (FOI) request - Access Decision**

On 1 January 2020, the Department of Home Affairs (the Department) received a request for access to a document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following document:

*EOIs that were issued an invitation to apply for a subclass 190 visa nominated by the VIC government in the period between 1/01/2019 -7/08/2019, showing:*

- a. date of invitation*
- b. ANZSCO code of occupation*
- c. occupation name*
- d. total points*
- e. primary applicant's English proficiency.*

**2 Authority to make decision**
