Freedom of Information (FOI) request - Access Decision

On 12 January 2020, the Department of Home Affairs (the Department) received a request for access to a document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

Data of Skilled independent visa (Subclass 189) as at 12/01/2020, the total number of EOI in submitted status for all occupations between 75-105 points, with/without professional year.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.
