Freedom of Information (FOI) request - Access Decision

On 17 January 2020 the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following documents:

A breakdown of residential postcodes for all Safe Haven Enterprise Visa holders. For example, how many SHEV holders are residing at postcode 2233, 2234 and so on. Please remove all other identifying information and for postcodes with less than 5 SHEV residents (but more than 0) please use <5 in order to ensure anonymity.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
