Freedom of Information (FOI) request - Access Decision

On 2 February 2020, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

EOI numbers for subclass 189 currently in submitted status for other engineering professionals in the following point categories:

- 90 or greater than 90 points till 2nd Feb 2020
- 85 points from 1st Nov'18 to 30th Jan'19

2 Authority to make decision
