Freedom of Information (FOI) request - Access Decision

On 13 March 2020, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following documents:

I would like to have the number of applications finalised and visa granted to each nationality (only top 15 for each subclass based of the number of visas) in subclasses 189(point tested streams) , 190 and 489 for the following fiscal years :

15- 16

16-17

17-18

18-19

Please provide the report for each fiscal year separately.

Also , I want both numbers : Visa granted and application completed . It is to be said that each application may contain one to few visas granted according to the number of secondary applicants .I want to know both numbers .

The top 15 nationalities could be ranked based on the number of visas granted .

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
