Freedom of Information (FOI) request - Access Decision

On Friday, 17 April 2020, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following:

1. *I would be grateful if you can provide statistics (applications received, number granted, number refused, point score of applicants) for 189 visa applications received from Apr 2019 to date.*
2. *I wish to know about the statistics of worldwide applicants on the whole as well as those originating specifically from Hong Kong SAR.*

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents.

3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the document relevant to the request
- the FOI Act

The internal review will be carried out by an officer other than the original decision maker and the Department must make a review decision within 30 days.
