were present for the initial part of the meeting s47F and s47F 3. however, they excused themselves once all members were present (prior to the commencement of agenda item 2).


1.03 – Update on application 241-20 Chloroquine Chemoprophylaxis Countermeasure against COVID19 (C4)


- 4. The Committee noted that:
