### Decision made under the Freedom of Information Act 1982 – Release in full

I refer to your request to the Department of Infrastructure, Transport, Regional Development and Communications (the department) received on 26 August 2020 for access to documents under the *Freedom of Information Act 1982* (FOI Act). You requested the following documents:

Any and all documents relating to decisions of the Classification Board and Classification Review Board regarding the Austria German film 'The Trouble With Being Born' 2020, directed by Sandra Wollner.

# **Authority**

I am an officer authorised by the Secretary to make decisions about access to documents in the possession of the department in accordance with s 23(1) of the FOI Act.

## Documents subject to this request

The department has undertaken a search of its records and has identified eight documents that fall within the scope of your request. Please note that there has been no classification decision that relates only to *The Trouble With Being Born* (TTWBB) by itself - the only decision in relation to TTWBB was in response to an application received seeking modification to the conditional cultural exemptions as set out in subsection 6C(e) of the *Classification* (*Publications, Films and Computer Games*) (*Conditional Cultural Exemption Rules*) Instrument 2015 as it applied to unclassified films to be screened as part of the Melbourne International Film Festival (MIFF). ### Irrelevant material

Where the giving of access to a document would disclose information that would reasonably be regarded as irrelevant to the request for access, section 22(1) of the FOI Act provides that it is possible for an agency to prepare an edited copy of the document, modified by deletions.

As the decision relates not to the specific film you are interested in but rather many films, you will note that there are limited specific comments in the documents in relation to TTWBB. Where this was non-specific but still related to all the films in general I have considered it in scope. Where the information is not relevant to TTWBB but rather relates to the festival as a whole or other films specifically, I have considered this irrelevant. The irrelevant material has been redacted from the documents.

#### Decision

I have made a decision to release the documents subject to your request in full, subject to deletion of irrelevant material.

I have decided not to impose a charge for processing your FOI request. The documents released to you in accordance with the FOI Act are enclosed.

# Publication of information in the FOI disclosure log

Section 11C of the FOI Act requires publication of released documents on the Department's online FOI disclosure log, subject to certain exceptions, including where publication of personal, business, professional or commercial information would be unreasonable. I have decided that the documents released will be published on the disclosure log.

## Your rights of review

An application for review by the Information Commissioner must be made in writing within **60 days** after the day you are notified of this decision.
