Freedom of Information (FOI) request - Access Decision

On 22 September 2020, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

The total number of applicants, as at 14 August 2020 (or later), that have been approved for conferral of Citizenship and are now waiting to attend a ceremony in the various Perth Metropolitan area councils.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

3 Relevant material
