Freedom of Information (FOI) request - Access Decision

On 31 October 2020, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

I would like to know the total number of applicants, as at 31 October 2020 (or later), that have been approved for conferral of Citizenship and are now waiting to attend a Citizenship Ceremony in the Queensland's BRISBANE Council area.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
