Attorney-General's: Ms Smith advised that there was currently a Bill before Parliament to allow ASIO to intercept on another law enforcement agency's behalf. It also included allowing the use of call data for missing persons and other minor amendments for information sharing. Ms Smith also advised that AGD was working at simplifying the TIA Act as well as stating there was no update on data retention.
