**Freedom of Information (FOI) request - Access Decision**

On 10 May 2021, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

**1 Scope of request**

2. *Onshore and offshore visa applications Granted for subclass 189 (points tested) for occupation 261313 by activity month, from 01/07/2020 as at 10/04/2021*
