#### Freedom of Information application

I refer to your application to the Department of the Premier and Cabinet (DPC) under DPC Circular PC031, 'Disclosure of Cabinet documents 10 years or older', seeking access to:

One document was identified as answering the terms of your application and I have determined to release this document in part.

A section of this document contains information relating to the personal affairs of multiple third parties. Under clause 6(1) of Schedule 1 to the Freedom of Information Act 1991 (the Act), information is exempt if releasing it would involve the 'unreasonable disclosure of information concerning the personal affairs of any person'. I have considered that the application of clause 6(1) requires two elements, one that the information contains the personal affairs of that person; and secondly that disclosure would be unreasonable and contrary to public interest. I have determined that this information falls within the category of 'personal affairs' as listed under section 4(1) of the Act, thereby meeting the first elements of this clause. Further, I have considered whether the disclosure of this information would be unreasonable. In doing so, I have considered the relevance of this information to the public and the likelihood as to whether the person in question would consent to disclosure. I have concluded that this information was likely obtained in confidence and through measures which would otherwise make it unavailable to the public. I have considered the factors in favour of public interest and determined that these factors are outweighed by the need to maintain personal confidentiality in this instance. Therefore, I have determined that this information meets the requirements of clause 6(1) and is thereby exempt pursuant to this clause.

Items on the agenda page not relating to the document you requested have also been removed.

#### Clause 6 – Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

# RE: APPOINTMENT OF A CHAIRPERSON, DEPUTY CHAIRPERSON, MEMBER AND DEPUTY MEMBER TO THE VETERINARY SURGEONS BOARD

#### 1. PROPOSAL

- 1.1 That the following persons be appointed as Chairperson, Deputy Chairperson, Member and Deputy Member of the Veterinary Surgeons Board for 3 years commencing 1 July 1993, pursuant to Sections 6(1)(a), 6(1)(b), 6(2)(a), 6(3) and 6(5) of the Veterinary Surgeons Act 1985. (See Appendix I for details.)
  - 1.1.1 Appointment of Mr David William Johns, LLB(Hons), GDLP, as Chairperson.
  - 1.1.2 Appointment of Mr Peter Michael Mullins, LLB as Deputy to Mr Johns.
  - 1.1.3 Appointment of Dr Rodney Stephen Babidge BVSc as a Member.
  - 1.1.4 Appointment of Dr Julia Mary Nicholls BVMS, MRCVS as Deputy to Dr Babidge.

#### 2. BACKGROUND

- 2.1 The Veterinary Surgeons Act 1985 came into operation on 1 July 1987.
- 2.2 The purpose of the Veterinary Surgeons Board established under this Act is to provide for the registration of veterinary surgeons and to regulate the practise of veterinary surgery for the purpose of maintaining high standards of competence and conduct by veterinary surgeons in South Australia.
- 2.3 The Veterinary Surgeons Board consists of 6 members, 5 of whom are appointed by the Governor on the nomination of the Minister of Primary Industries and the other (who shall be a veterinary surgeon) is appointed by the Governor on the nomination of the Australian Veterinary Association, South Australian Division.
- Pursuant to Section 6(3) of the Act, appointments to the Board are for a period of 3 years. (A table indicating the terms of office of all members is attached see Appendix II.)
- 2.5 Deputy Members may be appointed by the Governor under the provisions of Section 6(5) of the Act.

#### 3. <u>DISCUSSION</u>

#### 3.1 Consultation

#### 3.1.1 Chairperson

Mr David William Johns LLB(Hons), GDLP was nominated for this position by the Minister of Primary Industries.

#### 3.1.2 Member

Under the provisions of Section 6(1)(b) of the Act, the Australian Veterinary Association, South Australian Division (AVA), shall nominate a veterinary surgeon for appointment by the Governor.

A letter from the Honorary Secretary of the AVA dated 13 May 1993, nominated Dr Rodney Stephen Babidge BVSc for appointment as a Member and Dr Julia Mary Nicholls BVMS, MRCVS as Deputy to Dr Babidge (see Appendix III).

#### 3.2 <u>Cost</u>

There will be no increase in costs due to the proposed appointments of the Chairperson, Member and Deputies.

#### 3.3 Staffing

The appointments will have no effect on Public Service staffing levels.

#### 3.4 Balance of Interests

With the above appointments to the Board the balance of professional interests will remain as:

- 1 legal practitioner (Chairperson)
- 2 small animal veterinary practitioners
- 1 large animal (rural) veterinary practitioner
- 1 Government veterinary practitioner
- 1 "lay" person (ie neither a veterinary surgeon nor a legal practitioner).

This balance will be maintained by the appointment of the Deputy Members recommended herein.

The male/female ratio of the 6 Members will be 5 males and 1 female, while the male/female ratio of Deputy Members will remain as 4 males and 2 females.

#### RECOMMENDATIONS 4.

- That the Governor in Executive Council appoint the following persons to the 4.1 Veterinary Surgeons Board for 3 years from 1 July 1993, pursuant to the provisions of the Veterinary Surgeons Act 1985.
  - Mr David William Johns LLB(Hons), GDLP as Chairperson. 4.1.1
  - 4.1.2 Mr Peter Michael Mullins LLB as Deputy to Mr Johns.
  - Dr Rodney Stephen Babidge BVSc as a Member. 4.1.3
  - Dr Julia Mary Nicholls BVMS, MRCVS as Deputy to Dr Babidge. 4.1.4

# APPOINTMENT OF CHAIRPERSON, DEPUTY CHAIRPERSON, MEMBER AND DEPUTY MEMBER

## 1. Appointment Of Mr David William Johns LLB(Hons), GDLP, As Chairperson

- 1.1 Mr Johns has been nominated to fill this position by the Minister of Primary Industries, vice Mr Peter Michael Mullins LLB, whose term of office expires on 30 June 1993.
- 1.2 He was admitted to the Bar in 1982 and is a partner in the legal firm Lawson Downs Pty Ltd. His work is mainly associated with personal injury claims and commercial litigation, some of which involves acting for insurance companies.
- 1.3 His other interests include membership of the Law Society, The Civil Litigation Committee and the Mock Trial Committee.

## 2. Appointment Of Mr Peter Michael Mullins LLB As Deputy To Mr David Johns

- 2.1 Mr Mullins was appointed as the first Chairperson of the Board constituted under the Veterinary Surgeons Act 1985, on 1 July 1987.
- 2.2 He was admitted to the Bar in 1972 and is a senior partner in the legal firm Stanley and Partners. His work is concentrated mainly on litigation in the industrial arena.
- 2.3 He has completed two terms of office and has indicated that he does not wish to continue in the role of Chairperson. However, he has indicated his willingness to serve as Deputy to Mr Johns.
- 2.4 Mr Johns has indicated that he will be happy to have Mr Mullins appointed as his Deputy.

### 3. Appointment Of Rodney Stephen Babidge BVSc As A Member

- 3.1 Dr Babidge has been nominated as a Member by the Australian Veterinary Association, South Australian Division (AVA) pursuant to Section 6(1)(b) of the Act.
- 3.2 He is a veterinary surgeon who conducts a small animal practice at Hampstead Gardens.
- 3.3 He was President of the AVA in 1990.

- 4. <u>Appointment Of Dr Julia Mary Nicholls BVMS, MRCVS As Deputy To Dr Rodney Babidge</u>
  - 4.1 Dr Nicholls was appointed as a Member of the Board on 1 July 1987, on the nomination of the Australian Veterinary Association, South Australian Division, pursuant to Section 6(1)(b) of the Act. The AVA have now nominated her for appointment as Deputy to Dr Babidge.
  - 4.2 She is a veterinary surgeon who conducts a small animal practice at Prospect.
  - 4.3 Dr Babidge has indicated that he will be happy to have Dr Nicholls as his Deputy.
