**Infringement number IESL10944**

Thank you for letter email dated 3 March 2020 requesting a review of infringement number IESL10944, issued to Ms Aysel Danaci.

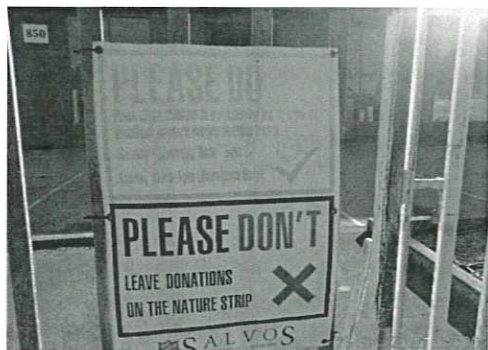
Council's Litter Enforcement Officer viewed CCTV footage of the driver of vehicle registration SUU793 dumping litter onto the nature strip outside the Salvo Store at 850 Cooper Street Somerton on 17 November 2020 at 7:51pm.

After inspecting the location, Council's Litter Enforcement Officer issued a 'Direction to Remove Litter' notice in accordance with section 45X of the *Environment Protection Act 1970*. This Notice directed Ms Danaci to remove and legally dispose of mixed items from 850 Cooper Street Somerton and provide a receipt of legal disposal by 5 December 2020. The Notice also advised if you failed to comply with the notice you will be liable to a fine of \$1983.00.

The Litter Officer ascertained the items had not been removed. As no contact had been made with the officer requesting an extension of time to comply with the direction, infringement notice IESL10944 was issued.

In addition, infringement notice IESL10162 was issued for "Deposit litter contrary to section 45E". As your application for internal review only relates to infringement IESL10944, payment of infringement IESL10162 is required by the due date shown on our most recent correspondence.

Whilst you have advised your wife was donating items, any item being donated to the Salvo's store must be donated in store during opening hours. Items cannot be left on the nature strip. Signage is clearly displayed on the fence and nature strip advising of this. Refer to images below.



The infringement notice cannot be withdrawn.

In accordance with the *Infringements Act 2006*, an application for internal review may only be made once in relation to any one infringement offence. Council is unable to accept any further application for review of this infringement.

### Your options

To avoid additional costs to the current balance of \$1983.00, the following options are available to you:




- Pay the infringement penalty and any Penalty Reminder Notice fees by the extended due date of **6 April 2021**.
- Apply in writing for a payment plan with Council.
- Request a payment arrangement with Fines Victoria. Applications should be submitted to Council in writing. Not all infringements are eligible.
- Elect to have the matter heard in the Magistrates Court (or Children's Court, if applicable).
- If you are eligible, an accredited organisation may apply to Fines Victoria for a Work and Development Permit (WDP) so you can work off your fine by non-financial means. See [www.justice.vic.gov.au/wdp](http://www.justice.vic.gov.au/wdp) for more information.
