Freedom of Information request — Notification of Decision

Thank you for your correspondence of 4 September 2021, in which you requested access under the *Freedom of Information Act 1982* (FOI Act) to documents held by the National Disability Insurance Agency (NDIA).

The purpose of this letter is to provide you with a decision on your request.

Scope of your request

You have requested access to documents about the National Disability Insurance Scheme (NDIS). Specifically, you requested access to:

"Please provide details on how many times the phrase:

"divert the resources of the NDIA"

has been used by the NDIA regarding FOI enquiries for the period 1 Jan 2020 until 4 September 2021.

Noting this statement has been used in senate estimate and public accountability forums, please include public expressions of this statement in your final total."

Decision on access to documents

I am authorised to make decisions under section 23(1) of the FOI Act. My decision on your request and the reasons for my decision are set out below.

The information you requested was not available in a separate written document at the time of your request. However, we have been able to produce a document containing the information you have requested. I have, therefore, treated your request as if it were a request for access to this document in accordance with section 17 of the FOI Act.

I have identified one document which falls within the scope of your request.

I have decided to grant access to this document in full.

The document was identified by conducting searches of NDIA's systems, using all reasonable search terms that could return documents relevant to your request, and consulting with relevant NDIA staff who could be expected to be able to identify documents within the scope of the request.

Delivered by the National Disability Insurance Agency I am satisfied that reasonable searches of the NDIA's document management systems have been conducted and sufficient enquiries made with relevant NDIA staff. I am satisfied all reasonable steps have been taken to locate the documents you have requested in part 2 of your request in relation to public statements, and I am satisfied that the documents cannot be found or do not exist.

In reaching my decision, I took into account the following materials:

- your correspondence outlining the scope of your request
- the nature and content of the documents falling within the scope of your request
- the FOI Act
- the FOI Guidelines
- consultation with relevant NDIA staff
- factors relevant to my assessment of whether or not disclosure would be in the public interest
- the NDIA's operating environment and functions.
