Yes, due diligence when we don't know the organisation. Should be part of the invitations assessment process. But BTW, it was a podcast interview where we talked about our model, SbD and combatting CSEM. We did not endorse any organisation or approach. We could get this from multiple angles - I recently did a 45 minute interview with JOY FM, an LGBTIQ station so could also get flack for engaging that community.

The lightning rod here is porn and as we further the RAS process, release the codes and continue down the AV path, there is likely to be more of this - so we will have to be aware and prepared with each of these milestones.

We will continue to monitor. The best remedy going forward will be to ensure due diligence on all speaking engagements. We don't see any advantage to be gained by engaging with individuals here.
