How to use this table

- **Instrument Number** This is the reference number given to the Instrument when it is created 'R' denotes instruments signed by the Repatriation Commission, 'MRCC' denotes *Military Rehabilitation and Compensation Act 2004* instruments signed by the Military Rehabilitation and Compensation Commission, 'SRCA' denotes instruments which have been signed under the *Safety, Rehabilitation and Compensation Act 1988* by the Military Rehabilitation and Compensation Commission, 'S' denotes an instrument signed by the Secretary to the Department of Veterans' Affairs and 'M' denotes an instrument signed by the Minister for Veterans' Affairs. The last number is the year the instrument was created. Older instruments were numbered with a given number and then year and then the relevant Commission.
- **Date signed** is the date the instrument was signed and sealed by the Commissions.
- **Title** By clicking on the links under Title below you will be taken to a TRIM document for each Instrument. Generic means there is no identified Division or Group against the APS Level.
- **Reference Tool** is linked to a work book in TRIM designed to provide the section of the Act and APS Level which has the power to enact it.
- **Act** this is list of the abbreviation of the Legislation the instrument is created under.
