





Ben McDevitt welcome to Offsiders.

BM

Thanks Gerard

Did Cronulla players definitively use performance enhancing drugs?

BM

Well Gerard at this stage we have a number of players who have admitted exactly that that they have used performance enhancing drugs.

GW

Are these players then to be regarded as drug cheats?

BM

Interesting question but it's not for me to name call. People will come to their own conclusions and decide to use that terminology. My job as the regulator of the code, and I note WADA code that we administer doesn't contain the word cheats but let's just talk about the facts here. What we've got is players who have taken performance enhancing drugs. That's a fact. These players have gone onto the field of play with those substances in their systems administered to them an unfair advantage. That's a fact. Players have admitted having these substances administered to them. That's a fact. Under the code each player is responsible for what enters their body. That personal responsibility is a fact. In relation to these particular players, their claim is that they took performance enhancing drugs unwittingly. They are saying were doped and they were duped and on the evidence that we have gathered that also is a fact and that entitles them to a reduction in the penalty and the use of these substances normally under the code carries a two year penalty. It is a fact that they have a claim here to be able to reduce that penalty to a one year penalty due to having no significant fault.

GW

So players took to the field with an unfair advantage. Ben, that being the case how are penalties that in practical terms amount to 3 matches and a couple of weeks of pre-season training how can that be regarded as proportional?

BM

This is really a difficult and complex situation. We've got to look at the circumstances of each case in a very specific and separate way. What we actually have here is an investigation that has gone on for months, and months and months. It's gone on under a very public spotlight. The fact these players have actually had the sword of possible issuance of notices against them, is actually something that can be counted lawfully under the interpretation of the code as a reason for being able to commence a backdating provision. What has occurred here is the players in facing a 12 month potential sanction have claimed that they should be given a backdating provision due to the fact there are issues about delays which are not attributable to the athlete. Things like ASADA and Gvt, Parliament was

required to amend the ASADA legislation once this investigation had already started in order for ASADA to be able to conduct the sort of inquiries and interviews it actually did. Don't forget this didn't start with a positive test. There hasn't been a single positive test in relation to these players at Cronulla so we've had a lot of delays not attributable to the players involved and that entitles them under the code to seek these backdating provisions. Whilst it might seem unfair to some and some would say three matches is too little of a penalty, let's remember the sanction is a 12 month sanction that will go on the record. Yes it's true it has been backdated, it has been backdated for logical reasons. and in terms of the advice here, let's just have a think about this. I have spoken to WADA throughout this investigation in terms of when I arrived. I've only been here for three months. I established an early relationship with David Howman, the director general of WADA and I've kept him in the loop on the progress of the investigation. The last time I spoke to him was yesterday, I spoke to him a couple of times the day before. He has been involved with this and has assured me that he has a level of comfort about where we have arrived here. In addition I've sought and had the views of Rich Young. Rich Young wrote the World Anti-Doping Code. I've spoken to him about these backdating provisions. I've said to him do you think it is fair and reasonable when you are at a point where players have already moved from a position of saying there's no significant fault, they're saying they were unwittingly subject to the administration of these substances, the evidence shows in all likelihood that that was the case and significant blame actually lies elsewhere and we can come onto that later but Rich Young says, I wrote the code, I wrote the provisions, these players would certainly be entitled on the basis of significant delays not due to them, to claim backdating penalties and that's where we've arrived at.

GW

As we sit here now how would you categorise the chances of WADA appealing these penalties?

BM

Well I think we're on extremely firm ground. I've been consulting with WADA and the advice I have from WADA is that they are very comfortable with how this has been handled and the landing point that we have arrived at. Obviously WADA, they will always retain their right to appeal. In fairness to them they haven't seen all the intimate, intricacies of this brief, they haven't been exposed to the thousands and thousands of pages of documents but they are aware of how it's panned out, the general flow of it, aware of what players have said, general nature of the evidence that is being produced. They'll never give an iron-clad guarantee, of course they'll reserve their right but I'm extremely comfortable that they believe what we have done here is consistent with the code and in accordance with the code and I can tell you as the administrator and guardian of the code here in Australia there is no way I would possibly allow us to get into a situation where what we were doing was in breach of the provisions of that code.

GW

Do you feel a moral obligation to the players to ensure the deal that was accepted is the penalty that is served?

BM

I have entered into an arrangement with these players. They were served notices giving them details, showing them quite considerable evidence that had been amassed against them following a long investigation. They were invited to respond to that, they were entitled to have discussions about what that might mean in terms of provisions of the code. Those discussions have taken place, our sense was there were legitimate claims for these players to be able to claim no significant fault to say they unwittingly received substances, to therefore mean that there, you could also go to a point where they could legitimately claim there were undue delays in this that were totally not attributable to them so where we landed was fair and appropriate and ASADA stands by the positions that we are at now and that is on no personal view of mine about favouritism or malice or ill-will against anybody else, it's on strict interpretation of the code.

GW

In what you would describe as the unlikely event that WADA did exercise its right to appeal, you would essentially stand with the players?

BM

Absolutely. It's not a matter of standing with the players. It's a matter of me as the guarding of the code, standing by the actions that we have taken and standing by the fact we have arrived at the point we have arrived at in terms of recommended sanctions, applied by the NRL, but in terms of the recommended sanctions and the backdating provisions and the entitlement to those provisions, we have done that in a fair and proper and consistent way and of course I will stand by the actions of this organisation but my strong view is you are talking something that is theoretical and that will just not happen because I know that WADA are comfortable with where we've come.

GW

Were the players this week presented with the evidence that you had gathered against them?

BM

They were presented with show cause notices which had an attachment to them which shows the general nature of the evidence which was gathered in support of our case. Obviously they were then in a position where they needed to determine what their response would be. The notices I gave to those players said you have 10 days in which to give me a submission to respond to these notices. They chose to respond in a shorter time period and make admissions and on that basis to seek access to these other provisions we have just discussed.

GW

ou have previously issued show-cause notices to Essendon players. Did the Cronulla letters contain more information of the specifics of the case against them than what you did with Essendon?

BM

I think that probably is correct. Probably the attachments to the documentation given to Essendon was not as comprehensive as that given to the Cronulla players and following the issuance of the documentation to the Essendon players I actually sought advice from the Australian Government Solicitor on this at to the level of documentation that we should make available at that point. Don't forget there's a series of steps here and every player is entitled to view all the evidence, it's at what point they get to see it all. The advice I got back from the Australian Gvt Solicitor was that they were of the feeling at the point of show cause notice we should give more evidence so that is what we've done in this case.

GW

If ASADA had been adequately set up and fortified in preparation for this investigation do you think the penalties would be harsher that we're seeing now?

BM

I fell that's a hypothetical question. The end state may well have been the same but may have been arrived at through different interpretations of the code which is a complex document. The reality is I don't think ASADA was ready for an investigation of this magnitude, and it's not just ASADA. I don't think any national anti-doping organisation in the world would have been ready for something of this magnitude, complexity, this enormity which was immediately made public and needed to be conducted under the public eye and in terms of resources and capabilities there significant delays in relation to, for example interviews where we had players ready for interview but for a variety of reasons we weren't ready to actually conduct those interviews until some months later, a reason right there that players could seek backdating of penalties just for that and it's fair and reasonable and I've got to do this without fear or favour or malice or ill-will. I have no special affinity involved in any of these matters. I have no favourite sport or code or anything else. All I'm doing is to the best of my ability interpreting the code as the regulator. I cannot allow emotion to take over here. There's the code this is the set of rules, this is what the investigation is showing us and this therefore is the way we've moved forward.

GW

You came to the job amid mounting pressure for ASADA to resolve these matters. Do you feel like you've held up your end of the bargain in recent days?

BM

I took this role on 90 days ago and I've got to say it had been running under a public spotlight for many many months. I said I would work at this with urgency but that I wouldn't sacrifice certainty for that urgency. The ASADA

team has worked hard and diligently and under constant pressure from the media and others to actually get this resolved but I've got to do it properly. On day 25 I issued the notices to Essendon after due consideration, after strong legal advice which I've had every step of the way, we've continued the work simultaneously in relation to the Cronulla matters. They weren't set aside, we've been working on them both continuously but it took longer, we got to where we were and again after legal advice when I felt I was comfortable and I'd reached a state of mind that I need to, and I don't issue show cause notices on a willy nilly basis, I issue them after due consideration, and on Tuesday I felt I had reached that point.

GW

How do you respond to John Fahey's accusation that Australia's anti-doping integrity is a joke?

BM

John Fahey is a man of great integrity and I have a great deal of respect for John and I've spoken to John several times over the past few months and I appreciate his wise counsel. The reality is that my job is as the regulator here I am responsible as the CEO I need to fulfil my responsibilities as I see them as being most appropriate. I need to liaise with WADA, I do that, I get constant advice from them and that heavily influences the actions I've taken with the best advice and experience I'm able to gather from them. I've also been influenced by the review conducted by Garry Downes in relation to these matters and again I can't go into the Garry Downes report. It's legally privileged but the Garry Downes position is consistent with where we have landed under these circumstances and so I can onl say I maintain my greatest respect for John and I believe he is a man of great integrity.

GW

Is Australia's anti-doping integrity intact as a result of what's happened this week?

BM

I believe everything that has happened this week is totally in line with my obligations, it is totally in line with the national anti-doping scheme. It follows months and months of extensive investigations conducted under the public spotlight very very good work conducted by investigators in bringing together evidence, extremely lengthy legal advice sought from multiple sources, including from the person who wrote the code so I'm very comfortable the system being what it is, the code being what it is, and that's what I've got to stick to and maintain the integrity of the code.

GW-

How do you answer the outcry from Olympic athletes who are outraged at what I suspect they see as blatant favouritism to populist domestic football.

BM

Well I can tell you from the person who is the regulator, I have no view about any favourable approach to any particular sport. We administer 93 separate sports across this country and we do it without fear or favour and in the 3 months that I've been in this role I haven't just issued show cause notices to two sports, I've issued 60+ notices to 6 different sports. Every athlete from every sport negotiates the same code. The same set of rules apply. Any athlete can apply, and they're entitled to do it under the provisions of the code and if they want to say and every circumstance is separate, I would like to apply for no significant fault if they can demonstrate that then it is applied. If they can apply for and want to claim substantial assistance then that is applied, it's assessed and applied. If they want to apply for backdating provisions for reasons of extended delays not attributable to them, they can apply for that, if they want to apply for timely admissions and for backdating in relation to that then they can. Look, athletes can say what they like, there's 93 sports, one set of rules, they each negotiate it separately as individuals and we apply the rules fairly and impartially and without favour.

GW

Will ASADA release a reasoned decision outlining why these players were found to have doped?

BM

I think in time it's fair and reasonable and I think we need to be as transparent as we can because as I said at first blush people might look at these penalties, these sanctions and think that's unfair, that doesn't seem appropriate to

me, so I think it is in our interest to be able to demonstrate and step through the investigation process, the way the code is actually applied, the way that individuals can actually apply for reductions or for a retro-active commencement of their period of ineligibility, I think that is in the public interest but I must hasten to add that right now isn't the time because right now this still isn't resolved. We've still got a number of players who have yet 10 days, or the remainder of the 10 days to actually respond to the infraction notices which I have issued and they may respond in a range of different ways and in all likelihood we will have a number of these matters that will end up before the tribunal so it's live, it's moving, it will be before the court, but in answer to your question, yes, at the end of the day here I would like to be able to lay all this out and let everybody see what the circumstances actually were here and how we have arrived where we are now.

GW

Have the players who have made admission been entered yet on the register of findings?

BM

Yes they have. The ADRVP actually convened last night and that panel has made its decisions and it's decisions were to actually place these names on its register of findings and again in terms of the process here, the end to end processes under the national anti-doping scheme and the framework that we use are quite long in terms of time frames and there's some good reasons for that in terms of players being able to seek legal redress, to appeal at multiple steps along the way so for some pretty good reasons they're very convoluted and can be quite drawn out. It my guarantee is that when somebody enters into this framework that wherever possible when it's in ASADA's court we will deal with these matters as effectively and efficiently as we can.

GW

Ben how would you depict the conduct of Stephen Dank in what you've become aware of?

BM

The notices that I issued on Tuesday relate to players who believe that they have doped, that they've been the subject of doping and they have now admitted that. They've also claimed, and as I said the evidence we have thus far is that they did this unwittingly, that they doped and were duped. They claim no significant fault, I accept that is applicable. In my view the fault doesn't go away. If the fault doesn't lie or significant elements of it don't lie with the player, then where do they lie? In my view when we're talking about these sort of scenarios there are responsibilities at a player level, there are responsibilities at a club level, and there are responsibilities at a code level and everybody at all levels need to be held accountable. In relation to Stephen Dank if what we have gathered in relation to Stephen Dank's activities is tested and is proven then my view and my strong recommendation is that Stephen Dank never ever should be allowed near any sporting venue or any athlete anywhere in the world, ever.

W

As a line of evidence what has been built against Dank?

BM

I've just expressed my view in relation to Dank. In relation to doping generally my sense is that for every doping offence, or for most doping offences particularly where you see something that seems to be quite broad and the sort of features we're seeing here, then there are people above that. There are people involved in trafficking, there are people involved in aiding and abetting, there are people involved in encouraging activities, there are duty of care issues, there are people who turn a blind eye wilfully to what's happening, there are people who don't ask questions, there are people in positions of authority, in positions of significant influence over athletes who need to be held accountable and in this case I'll continue the ongoing discussions with David Smith and with Nick Weeks and his team, and they've put in a lot of effort and energy in this and all I'm sensing is resolve to work with us to make sure those people are also dealt with in an appropriate manner.

GW

Has Stephen Dank been placed on the register of findings?

ВM

Yes he has been placed on the register of findings. and I have written letters to both the heads of the NRL David Smith and the head of the AFL (***** edit) in relation to Mister Dank.

GW

What have you asked the NRL and AFL to do in relation to Dank?

BM

What I've asked them to do is issue infraction notices against Mister Dank and I have recommended that I believe he should be subject to a penalty of a lifetime ban.

GW

Is there any other action ASADA can take against him?

BM

My mandate is limited to enforcement of the national, Australia's national anti-doping scheme which is drawn from the provisions of the World Anti-Doping Code. Sports administrations have a range of other activities and actions that they can take beyond what I can take. I've got to stick to anti-doping violations and to the range of possible sanctions that can be brought down within that regime.

GW

Ben what are you able to tell us about the case of Sandor Earl?

BM

I can say very little in relation to the case of Sandor Earl. I know it is in the public arena that Sandor Earl is at the moment, there are court matters that are being heard in relation to Sandor Earl's appeal to the administrative appeals tribunal. That's his right and again when we talk about the end-to-end processes here he has chosen to make that decision and my only point there would be that the circumstances, without going into detail from my perspective relating to Sandor Earl, as opposed to the sort of matters we've been talking about this morning, are absolutely fundamentally different and I think that's about all I can say.

GW

So has he been treated fairly on what you've just said?

BM

I believe absolutely he has been fairly treated.

What needs to be made apparent in all of these matters is what we are talking about here is not decisions made by Ben McDevitt on Tuesday of this week or Ben McDevitt on Day 25 of being in the job in relation to issuing notices against Essendon, what we are talking about here is decisions made by athletes in 2011 and 2012 and we need to bear that in mind.

Are you trying to bring matters at Essendon to a close before the Federal Court ruling is brought down?

ВM

Absolutely not. That would be entirely inappropriate and in fact that would be quite contemptuous. We have a learned Federal Court Judge, Justice Middleton who has heard 3 days of extensive argument, legal debate, I am respecting that process, I'm awaiting his judgement on those matters and I would do nothing whatsoever to try to circumvent any of those processes or do anything which would impact in any way on the Essendon players involved there because that would be entirely inappropriate.

So there are no active offers before Essendon players from ASADA at the moment?

BM

Absolutely not.

What will you do when Justice Middleton hands down his findings?

BM

That's a really difficult question. The first thing I'll do is seek legal advice, I'll consider the finding and the ramifications of that finding for ASADA and for the other parties involved and I will reassess it. In fairness I would reassess it as quickly as possible then I would consider what further options would be available to ASADA in those matters.

Do you hold to you previous determination that you will continue to pursue this case regardless of the ruling?

Well Gerard as I've said I'm passionate about knowing what happened at Essendon in 2012. I think we need to actually know whether or not the environment of experimentation described by Switkowski was true. Did that actually exist? What I can't do is I can't say this will forge on regardless when I don't know what Judge Middleton is going to determine and when I don't know exactly for example if notices were permanently set aside, for example, and I would hope that wouldn't be the case but if that was the case then quite frankly I might be in a position where I'm legally restrained an unable to take certain other action but all I can say to you is yes, I believe it's in the public interest to know what happened at Essendon in 2012 and I remain committed to that as an objection.

Are the delays experienced in the process the same for Essendon players as they were for Cronulla players?

BM

Look again it's just an extraordinarily difficult question to answer because the circumstances involved here in many ways are just so different.

Is it possible though that in future then Essendon players could be offered the same backdated bans as what were offered to Cronulla players?

BM

There is just no way that I could contemplate answering that question at this point in time until I'm able to fully consider the judgement which will come from Justice Middleton and the implications of that for all parties.
