Freedom of Information (FOI) request - Access Decision

On 10 October 2021, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

1. Data of Skilled independent visa (Subclass 189) as at 10/10/2021, the total number of EOI in submitted status for 2611 and 2613 occupations between 75-105 points, with/without professional year.

2. Data of Skilled independent visa (Subclass 189) granted between 01/01/2021 and 10/10/2021 for 2611 and 2613 occupations between 75-105 points, with/without professional year.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

3 Relevant material

- the terms of your request
- the document relevant to the request
- the FOI Act

- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)

4 Document in scope of request

In accordance with section 17 of the FOI Act, in relation to Part 2, the Department has used its computer system to produce one document that contains information that falls within the scope of your request. The data produced in the document existed in the possession of the Department on 10 October 2021 when your FOI request was received.

5 Decision

7 Your Review Rights

Internal Review
