I refer to your request for access to documents relating to proof of germ pathogens under the Freedom of Information Act 1982. I have taken your request to be for: "documentation that proves an isolated virus or bacteria (separated from all non-identical particles) is pathogenic to an organism or pure tissue culture."

I am writing to advise you of my decision.

I am authorised under section 23(1) of the FOI Act to make decisions in relation to FOI requests.

Decision

All reasonable steps have been taken to find the documents referred to in your request including consultation with the relevant policy and program areas.

Thorough searches have been conducted of the Commission's file management system.

I am satisfied that the searches conducted were thorough and all reasonable steps have been taken to locate documents relevant to your request. I am satisfied that the documents referred to in your request do not exist. As a consequence, I refuse your request for access to the documents referred to in your request pursuant to section 24A of the FOI Act.

Review rights
