**Freedom of Information (FOI) request - Access Decision**

On 7 February 2022, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following document:

*Can you please let us know how many people are waiting for the ceremony in Sunshine Coast Council Queensland 4558 on 07/02/2022?*

*The upcoming ceremony is scheduled after 8th March 2022 and the estimated number of invitations to be sent?*

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

**3 Relevant material**

In reaching my decision I referred to the following:

- the terms of your request
- the document relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)

- advice from Departmental officers with responsibility for matters relating to the document to which you sought access

#### **4 Document in scope of request**

In accordance with section 17 of the FOI Act, the Department has used its computer system to produce one document that contains information that falls within the scope of your request. The data produced in the document existed in the possession of the Department on 7 February 2022 when your FOI request was received.

**Note:** We cannot provide upcoming citizenship ceremony dates or how many people will be invited for each ceremony as local government councils determine the date a ceremony will be held and there is no set number of people who are invited to attend a ceremony hosted by local government councils.

#### **5 Decision**

The decision in relation to the document in the possession of the Department which falls within the scope of your request is as follows:

- Release one document in full

#### **7 Final decision on charge**

On 8 March 2022 the Department issued you with a notice of the preliminary charge in the amount of **\$15.00** to process your request, which includes the first five hours of decision-making at no cost.

On 10 March 2022, the Department received your payment of **\$15.00** - the total charge indicated in the preliminary charges notice issued by the Department.

As you have paid the full amount required, the Department is now releasing the document to you. If you are dissatisfied with my decision to impose charges, your review rights are set out in the paragraph titled "Your Review Rights" below.

#### **8 Your Review Rights**

##### Internal Review

If you disagree with this decision, you have the right to apply for an internal review by the Department of this decision. Any request for internal review must be provided to the Department within 30 days of you being notified of the decision. Where possible please attach reasons why you believe a review of the decision is necessary. The internal review will be carried out by an officer other than the original decision maker and the Department must make a review decision within 30 days.
