Freedom of Information (FOI) request - Access Decision

On 17 February 2022, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

I would like to know the total number of citizenship applicants from the City of Ryde that are currently waiting for their citizenship ceremony. Please send the total number of applicants that were waiting at the end of each month from October 2021 to January 2022.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
