**Freedom of Information (FOI) request - Access Decision**

On 11 March 2022, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following document:

*I would like to know the number of people who whose applications for Australian citizenship by conferral had been approved by 31 Dec 2021 and who were waiting to attend an Australian citizenship ceremony at SA City of Salisbury Council as at 31 January 2022 and 11 March 2022 (or later).*

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
