**Request Under the *Freedom of Information Act 1982*
For Access to Documents**

I refer to your request under the *Freedom of Information Act 1982 (FOI Act)* received by this office on 9 January 2015 in which you sought access to:

Copies of any correspondence between Mr Beau Dreux from the Office of the Assistant Treasurer and ASIC on or around 8 October 2014 seeking information on behalf of Mr Michael Sukkar MP in relation to superannuation entitlements in relation a superannuation fund that has been known as The Provident Fund, the Elders IXL Superannuation Fund and the AusBev Superannuation Fund.

I am an authorised decision-maker for the purposes of section 23 of the FOI Act.

Relevant Legislation

Section 24A(1) of the FOI Act states that:

An agency or Minister may refuse a request for access to a document if:

- (a) All reasonable steps have been taken to find the document and
- (b) The agency or Minister is satisfied that the document:
 - (i) ...; or
 - (ii) does not exist

Decision

I have ensured that all reasonable steps have been taken to find the document or documents the subject of your request. I am satisfied that the document or documents do not exist. Accordingly, your request is refused pursuant to section 24A of the FOI Act.

Review Rights

You may, within 30 days after the day on which you have been notified of this decision, apply in writing to ASIC for a review of my decision by another ASIC officer under section 54B of the FOI Act. 3. You may lodge a complaint to the Commonwealth Ombudsman in respect to the conduct of ASIC in the handling of this request. Correspondence should be addressed to the Commonwealth Ombudsman - GPO Box 442 CANBERRA 2601.
