***Re. Freedom of Information Request***

The purpose of this letter is to give you a decision about access to documents that you requested under the *Freedom of Information Act 1982* (FOI Act).

On 21 April 2022 you requested access to:

*"I would like to access the previous editions of the following publication:*

*DFAT COUNTRY INFORMATION REPORT SRI LANKA*

*I would specifically like the ones that were in use in between 2010-2012 - I have been unable to locate previous versions online."*

I am authorised under section 23 of the FOI Act to make decisions in relation to FOI requests, and have been appointed to be the decision maker on your request.

Thorough searches conducted by the department found no documents relevant to your request.

After taking all reasonable steps to find the documents, I am satisfied that they do not exist. I therefore refuse your request under section 24A(1) of the FOI Act.

No documents exist as the Department of Foreign Affairs and Trade did not start producing Country Information Reports for protection status determination purposes until mid-2013.
