## Re. Freedom of Information Request

The purpose of this letter is to give you a decision about access to documents that you requested under the *Freedom of Information Act 1982* (FOI Act).

On 12 May 2022, you requested:

a copy of the full text of the AUKUS (Australia, United Kingdom, United States) technology transfer agreement, announced by Australia's Prime Minister September 2021.

I am authorised under <u>section 23 of the FOI Act</u> to make decisions in relation to FOI requests, and have been appointed to be the decision-maker on your request.

Searches conducted by the AUKUS Taskforce found no documents matching the description in your request.

In accordance with section 24A(1) of the FOI Act, your request for access to documents is refused as all reasonable steps have been taken to find the document and I am satisfied that the document does not exist.
