

## **Background**

As I explained on the phone, the Freedom of Information Amendment (New Arrangements) Bill

2014 was introduced into the Australian Parliament last week. The Bill:

- abolishes the Office of the Australian Information Commissioner (OAIC)
- amends the *Privacy Act 1988* to establish the position of an 'Australian Privacy Commissioner'. Timothy Pilgrim will continue as the Australian Privacy Commissioner for the remainder of his appointment
- transfer the current staff of the OAIC to the Australian Human Rights Commission
- requires the Australian Human Rights Commission to provide assistance to the Australian Privacy Commissioner, including by making staff available and providing administrative support to enable the Australian Privacy Commissioner to undertake the functions set out in section 27 of the Privacy Act
- those staff 'made available' to the Australian Privacy Commissioner will be subject to the direction of the Australian Privacy Commissioner and not the Australian Human Rights Commission.

You will note that, while the legislation establishes a statutory position of 'Australian Privacy
Commissioner', it does not establish an 'Office of the Australian Privacy Commissioner'.

#### Hello all

As I have expressed to a number of you individually I am committed to taking a positive approach to making the arrangements that are being established through this Bill work effectively to ensure the ongoing efficient administration of the privacy functions.

While I understand and appreciate the issues raised by Professor Triggs, particularly in respect of ensuring the independence of the Australian Human Rights Commission (AHRC), my agreement to the amendments outlined below are subject to seeing revised drafts of both the Bill and the Explanatory Memorandum (EM). In particular, any changes to ss43A(3) as proposed by Professor Triggs would need to be supported by a further strengthening and clarifying of the intent of that clause, both within that clause and also within the EM.

While there has been focus through this most recent redrafting exercise on ensuring the independence of the AHRC, and correctly so, this could appear to be increasingly at the expense of the independence of the Privacy Commissioner.

As you would appreciate, while these arrangements may not be entirely dissimilar to other administrative arrangements within Commonwealth Agencies they do place me and future Privacy Commissioners in the position of being responsible for the quite diverse functions under the Privacy Act while ultimately not having staffing or budgetary control or responsibility. As I have discussed with officers of the AGD, the arrangement will, in part, rest on the cooperative approach of both the President and the Privacy Commissioner on matters such as the President agreeing to delegate their functions to the Privacy Commissioner in terms of recruiting staff, and the Privacy Commissioner being able to independently enter into a financial Memorandum of Understanding (such as those currently in place) and to be able to undertake basic financial activities for the administration of the privacy functions. While these issues may seems mundane they do underpin the ability of the Privacy Commissioner to effectively undertake the privacy function. As I have said, while I am committed to making these arrangements work, I would be concerned about any further changes that may lead to perceptions within the business and broader community about the independence of the Privacy Commissioner given the increasing prominence of this issue within the community.

On a final matter, I am unsure as to what specific technical legal inconsistencies may be addressed next year and what that process is. This has not be raised with me by AGD as part of the development of this Bill, and I would appreciate knowing what this refers to.







### Dear OAIC colleagues

The Senate did not debate the Freedom of Information Amendment (New Arrangements) Bill 2014 before it rose yesterday. The Senate next sits on 9 February.

From a legal standpoint the OAIC will continue operations. However, as you are well aware, the Budget allocation for FOI work was to cease on 31 December. The OAIC has been implementing the Budget decision and the Canberra office will close today. James and John continue in their Commissioner roles, working from home; and Alison finishes work today (about which I'll be writing separately).

Clearly there are matters to be discussed between the office and the Attorney-General's Department, about operations generally, and specifically the discharge of FOI and privacy functions from 1 January. The context for those discussions is that the Government's policy intention announced in the Budget is clear, it has been substantially implemented at an operational level, and the Bill before the Parliament has not been rejected but simply not debated by the Senate.

Once again, it has been easier to work through this uncertainty because of the hard work, understanding and good judgement of OAIC staff. A special thanks from the Executive.

We will give you an update next week after Timothy and Angelene have returned and we have had an opportunity to further progress the discussions.

As discussed there are two significant outstanding legal issues that need to be settled concerning the Canberra arrangements and your old offices.

1. Pending the restructure of the OAIC entity the Canberra assets scheduled to be transferred to the AGD are of course still the property of the OAIC and make up a material amount on the OAIC balance sheet.

The major asset in Canberra is the office fit out – current book value between \$600-\$700k. There may also be some plant and equipment. Your legal area (do you have one?) or our legal area will need to draft some type of licence to give the AGD use of this fitout pending the restructure.

2. The OAIC is locked into a property sublease with AGD and they need to release you from it.

If you would like AHRC legal to investigate preparing a licence for AGD to use your fitout and other stuff please advise.
