



We have undertaken a series of third party consultations but are still awaiting numerous responses. Responses we have received from third parties have indicated a lack of consent to disclose some or all of the material concerning the third parties.

On 20 January 2022 the Department sought a 15AA extension of time from the applicant, to which no response was received. An extension was granted by the OAIC on 2 February 2022 for 14 days under section 15AB. After this extension was granted, the Department identified several third parties to be consulted prior to the release of any documents.

Following initial difficulties locating the request report which were outlined in our extension of time application (RQ22/00357). Internal business area consultations were undertaken on the nature of the report and it was decided that a series of third party consultations would be appropriate. On 16 February 2022 the applicant was notified of the requirement to undertake consultations and the subsequent 30 day extension of time.

We have undertaken consultations but are still awaiting a response from a several third parties. Due to the historical nature of the report, the department also encountered some difficulties obtaining current contact information for some of these third parties.
