**Freedom of Information (FOI) request – Access Decision**

On 22 July 2022, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following documents:

*Number of people whose application for Australian citizenship by conferral has been approved and who were waiting to be allocated to attend an Australian citizenship ceremony at various Melbourne urban region councils listed below.*

- 1. City of Melbourne*
- 2. City of Port Phillip.*

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.

**3 Relevant material**

In reaching my decision I referred to the following:

- the terms of your request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)

- advice from Departmental officers with responsibility for matters relating to the documents to which you sought access

The Department has identified one document as falling within the scope of your request. This document was in the possession of the Department on 22 July 2022 when your request was received.

In addition, in accordance with section 17 of the FOI Act, the Department has used its computer system to produce one document that contains information that falls within the scope of your request. The data produced in the document existed in the possession of the Department on 22 July 2022 when your FOI request was received.

#### **7 Final decision on charge**

On 9 August, 2022 the Department issued you with a notice of the preliminary charge in the amount of **\$25.00** to process your request, which includes the first five hours of decision-making at no cost.

On 10 August, 2022, the Department received your payment of \$25.00 - the total charge indicated in the preliminary charges notice issued by the Department.

As you have paid the full amount required, the Department is now releasing the documents to you. If you are dissatisfied with my decision to impose charges, your review rights are set out in the paragraph titled "Your Review Rights" below.

#### **8 Your Review Rights**

##### Internal Review

If you disagree with this decision, you have the right to apply for an internal review by the Department of this decision. Any request for internal review must be provided to the Department within 30 days of you being notified of the decision. Where possible please attach reasons why you believe a review of the decision is necessary. The internal review will be carried out by an officer other than the original decision maker and the Department must make a review decision within 30 days.
