Freedom of Information request — Notification of Decision

Thank you for your correspondence of 6 September 2022, in which you requested access to documents held by the National Disability Insurance Agency (NDIA), under the *Freedom of Information Act 1982* (FOI Act).

The purpose of this letter is to provide you with a decision on your request.

Scope of your request

You have requested access to the following documents:

"Under the Freedom of Information Act, please provide all ministerial briefings prepared for the Hon Bill Shorten since coming into office this year."

Decision on access to documents

I am authorised to make decisions under section 23(1) of the FOI Act. My decision on your request and the reasons for my decision are set out below.

I have decided to refuse your request for access under section 24A of the FOI Act. The reasons for my decision are set out below.

In reaching my decision, I took the following into account:

- your correspondence outlining the scope of your request
- the FOI Act
- the FOI Guidelines published under section 93A of the FOI Act
- consultation with relevant officers of the NDIA
- the NDIA's operating environment and functions.

Reasons for decision

Refuse a request for access (section 24A)

Section 24A of the FOI Act provides that an agency may refuse a request for access to a document if all reasonable steps have been taken to find the document and the agency is satisfied that the impact of processing the request would be substantial and unreasonable.

I have conducted searches of the NDIA's documents management systems and made enquiries with NDIA staff. These enquiries have revealed that the NDIA is in possession of more than 1000 documents matching the scope of your request.

Paragraph 3.111 of the FOI Guidelines states that a 'practical refusal reason' exists if the work involved in processing the request would substantially and unreasonably divert the resources of an Agency from its other operations (s 24AA(1)(a)(i)).
