Freedom of Information request — Notification of Decision

Thank you for your correspondence of 9 September 2022, in which you requested access to documents held by the National Disability Insurance Agency (NDIA), under the *Freedom of Information Act 1982* (FOI Act).

The purpose of this letter is to provide you with a decision on your request.

Scope of your request

You have requested access to the following documents:

"I am requesting that you kindly provide high-level statistics reports of NDIA decisions overturned by the AAT for the last 18 months relating to all matters."

Decision on access to documents

I am authorised to make decisions under section 23(1) of the FOI Act. My decision on your request and the reasons for my decision are set out below.

I have decided to refuse your request for access under section 24A of the FOI Act. The reasons for my decision are set out below.

In reaching my decision, I took the following into account:

- your correspondence outlining the scope of your request
- the FOI Act
- the FOI Guidelines published under section 93A of the FOI Act
- consultation with relevant officers of the NDIA
- the NDIA's operating environment and functions.

Reasons for decision

Refuse a request for access (section 24A)

Section 24A of the FOI Act provides that an agency may refuse a request for access to a document if all reasonable steps have been taken to find the document and the agency is satisfied that the document cannot be found or does not exist.

The relevant line area has conducted searches of the NDIA's documents management systems and made enquiries with NDIA staff. These searches have revealed that the NDIA is not in possession of documents matching the scope of your request. This is because the Agency does not possess the structured data required for your request.

Notwithstanding the above, the line area has indicated that the narrative and data in the Quarterly Report to Disability Ministers, specifically pages 81-88 of the June 2022 Quarterly Report, may be of interest to you. This information is publicly available, and is able to be located via the following link:

Quarterly Reports | NDIS.

I am satisfied that all reasonable steps have been taken to locate the documents you have requested and that the documents do not exist. I have, therefore, decided to refuse access to your request in accordance with section 24A(1)(b)(ii) of the FOI Act.
