Re: Freedom of Information (FOI) Request

I refer to your current freedom of information request relating to ministerial negotiations relating to the Trans-Pacific Partnership agreement. On 3 March 2015, you revised the scope of your request to the following:

"A list of all business representatives, industry association representatives or lobbyists that accompanied the Minister for Trade, the Hon Andrew Robb MP to ministerial negotiations related to the Trans-Pacific Partnership (TPP) since September 2013 when Mr Robb was appointed to the Trade Portfolio. Please take the request to mean those who were invited to attend and/or who attended, even if they did not specifically accompany the Minister".

I am authorised under section 23 of the FOI Act to make decisions, and have been appointed to be the decision-maker on your request in line with departmental procedures.

I advise that a search of the Department's file records by staff at the Office of Trade Negotiations has not identified any document relevant to the scope of your request. I am advised that some industry representatives made themselves available to Australian negotiators on the sidelines of TPP Ministerial meetings held since September 2013 of their own accord, and therefore, the Department does not have a list or record of these representatives.

I am therefore unable to meet your request in accordance with the provisions of section 24A(1)(b)(ii) of the FOI Act, as DFAT holds no documents relevant to your request.

Please find your rights of review outlined below.

Internal review
