## Re: Freedom of Information (FOI) Request

I refer to your letter of 19 February 2015 in which you seek access under the provisions of the *Freedom of Information Act 1982* (FOI Act) to:

"Any and all of correspondence between the Minister of Foreign Affairs The Hon Julie Bishop and the Prime Minister The Hon Anthony Abbott, Regarding the Charlie Hebdo Shootings."

I am authorised under section 23 of the FOI Act to make decisions, and have been appointed to be the decision-maker on your request in line with departmental procedures.

I advise that a centralised search of the Department's file records has failed to identify any documents relevant to the scope of your request. I also tasked the line areas which deal with ministerial-level correspondence as well as the subject matter in which you are interested to undertake searches in their databases and electronic filing systems. These searches have not yielded any results. The Foreign Minister's Office has also advised that it holds no relevant documents.

I am therefore unable to meet your request in accordance with the provisions of section 24A(1)(b)(ii) as DFAT holds no documents relevant to your request.
