NOTICE OF DECISION

I refer to your request of 20 February 2015 to the Anti-Doping Research Panel seeking access under the *Freedom of Information Act 1982* (FOI Act) to:

- Any documents or analysis outlining and explaining effects that banned substances have on the behaviour of athletes
- A list of all projects funded under the Anti-Doping Research Panel from January 1, 2012 to February 18, 2015

Your FOI request was addressed to the Anti-Doping Research Panel (Panel) which no longer exists. However the Department of Health (Department) retains the documents relating to the Anti-Doping Research Programme (Programme) responsible for overseeing the Panel.

I am writing to advise you of my decision following review of the Programme's documents.

Decision

The Department has been unable to locate any Programme documents or Programme analysis outlining or explaining the effects that banned substances have on the behaviour of athletes. I must therefore refuse access pursuant to section 24A of the FOI Act on the basis that the documents sought do not exist.
