On 23 March 2020 the Commonwealth of Australia as represented by Department of Health (Commonwealth) entered into a written agreement with ProMedical Equipment Pty Ltd (ProMedical) pursuant to which ProMedical was to supply 500,000 Wondfo SARS-CoV-2 Antibody Test Kits (Test Kits) for use in the Commonwealth's National Medical Stockpile (Contract).

The Contract relevantly requires ProMedical to:

- 3. an explanation as to the failure to comply with its contractual obligations.

Re: Goods contract for the provision of COVID-19 point of care testing kits as between the Commonwealth of Australia as represented by the Department of Health and ProMedical Equipment Pty Ltd

I refer to the above contract (Contract), my letter of 19 May 2020, and your reply letter of 20 May 2020.

The Contract specifically requires ProMedical Equipment Pty Ltd (ProMedical) to supply 500,000 Wondfo SARS-CoV-2 Antibody Test Kits to the Commonwealth of Australia as represented by the Department of Health (Commonwealth).

The Commonwealth has not agreed to ProMedical supplying SARS-CoV-2 Antibody Test Kits manufactured by a party other than Wondfo or otherwise agreed to ProMedical's obligations under the Contract being varied.

In these circumstances, your letter (which suggests that ProMedical is authorised to supply test kits manufactured by Qingdao Hightop Biotech Co., Ltd) does not:

- substantiate ProMedical's ability to perform the Contract; or
- provide a reasonable explanation as to ProMedical's failure to comply with its contractual obligations.

The Commonwealth requires ProMedical to urgently (and by no later than 4pm Monday 25 May 2020) provide:

- satisfactory evidence of its ability to lawfully deliver 500,000 <u>Wondfo</u> SARS-CoV-2 Antibody Test Kits (Required Test Kits) to the Commonwealth, including copies of relevant purchase orders, contracts, licences and approvals; and
- written confirmation that the Required Test Kits will be delivered to the Commonwealth without further delay.

In the event ProMedical fails to do so, the Commonwealth will treat this as evidence that ProMedical is unable or unwilling to discharge its obligations under the Contract and may exercise its resultant right of termination. The Commonwealth reserves all of its rights, both under the Contract and at law.

Thank you for your email. I would like to bring the following to your attention in response to your letter on the 19<sup>th</sup> May 2020 and 22<sup>nd</sup> May 2020.

When COVID-19 Virus enters the body, the human body produces two types of antibodies in response. They are IgM and IgG. Detecting these antibodies are the base of any antibody rapid test kit on the market. IgM is the first antibody to be produced and 4-7 days after, IgG will be produced.

Wondfo SARS-CoV-2 Antibody Test (Lateral flow method) only tests for detection of IgG antibody which is produced around 4-7 days after release of IgM antibody. Therefore, if used for early detection, this will give false negatives which in turn is low in accuracy and sensitivity.

Qingdao Hightop SARS-CoV-2 IgM/IgG Antibody Rapid Test detects for both IgM and IgG which can be used for early detection as well as late detection making it a much more superior product with a higher sensitivity and accuracy compared to Wondfo SARS-CoV-2 Antibody Test (Lateral flow method). Therefore, we suggest that the Government receives 500,000 of the Qingdao Hightop SARS-CoV-2 IgM/IgG Antibody Rapid Test which is ARTG approved and listed for the same price as the Wondfo SARS-CoV-2 Antibody Test (Lateral flow method).

Furthermore, the letter we received from you on the 19<sup>th</sup> May 2020 requested and I quote '1. advice (and supporting documentation) as to whether or not the Test Kits are (or will be) approved and listed on the ARTG'. ## Re: Goods contract for the provision of COVID-19 point of care testing kits between the Commonwealth of Australia as represented by the Department of Health and ProMedical Equipment Pty Ltd

I refer to the above contract (Contract) and our previous correspondence.

#### **Requirements of the Contract**

The Contract required ProMedical Equipment Pty Ltd (ProMedical) to supply 500,000 Wondfo SARS-CoV-2 Antibody Test Kits (Required Test Kits) to the Commonwealth of Australia as represented by the Department of Health (Commonwealth) by 3 April 2020.

This obligation has not been amended or varied by the Commonwealth, either to allow for ProMedical to supply SARS-CoV-2 IgM/IgG Antibody Rapid Test Kits manufactured by Qingdao Hightop Biotech Co., Ltd (Qingdao Hightop Test Kits) or otherwise.

## ProMedical's inability to perform the Contract

By my letters of 19 and 22 May 2020, the Commonwealth made requests of ProMedical to (within specified timeframes, which have now lapsed):

- advise (and provide supporting documentation) as to whether or not the Required Test Kits were (or would be) approved and listed on the Australian Register of Therapeutic Goods;
- provide satisfactory evidence of its ability to lawfully deliver the Required Test Kits; and
- provide written confirmation that the Required Test Kits would be delivered to the Commonwealth without further delay.

Your reply letters of 20 and 25 May 2020, which concerned the proposed supply of Qingdao Hightop Test Kits, in no way addressed the Commonwealth's requests or evidenced ProMedical's ability to deliver the Required Test Kits.

In these circumstances, and noting that the Contract does not allow for the supply of Qingdao Hightop Test Kits instead of the Required Test Kits, it is clear that ProMedical is either unable or unwilling to perform its obligations under the Contract.

#### Election to terminate the Contract and reservation of rights

Pursuant to clause 14(a) of the Contract, the Commonwealth may issue a Notice to immediately terminate the Contract if ProMedical does not deliver the Goods as specified in the Contract (including by any delivery date) or the Commonwealth forms the view that ProMedical will be unable to deliver the Goods as specified in the Contract (including by any delivery date).

By reason of ProMedical's failure to:

- deliver the Required Test Kits to the Commonwealth by 3 April 2020; and/or
- provide satisfactory evidence of its ability to deliver the Required Test Kits to the Commonwealth,

a right of termination has accrued to the Commonwealth under clause 14(a) of the Contract.

The Commonwealth hereby provides Notice of its election to exercise this right of termination. The Contract is now terminated with immediate effect.

Further, through its conduct to date, ProMedical has repudiated its obligations under the Contract. In terminating the Contract, the Commonwealth has accepted this repudiation rather than electing to keep the Contract on foot.

The Commonwealth reserves its rights in relation to the termination of the Contract and generally, including (without limitation) its right to recover any damages suffered by reason of ProMedical's failure to perform its obligations under the Contract.
