Your Freedom of Information request - Charges

I refer to your request, dated 27 February 2023 and received by the Department of Climate Change, Energy, the Environment and Water (**Department**) on 27 February 2023 for access under the *Freedom of Information Act 1982* (Cth) (**FOI Act**) to a range of documents. Your FOI request, as revised on 24 March 2023 is as follows:

'In regards to your recommendation that I rescope my prior request to receive all documentation and discussion regarding the addition of the Cuttlefish Coast Sanctuary Zone to the National Heritage List, I wish to narrow the scope to focus exclusively on "all correspondence to and from stakeholders from the site's nomination through to its eventual listing.'

Preliminary assessment of the Charge

In accordance with section 29 of the FOI Act, I have decided that you are liable to pay a charge for the processing of your request. My preliminary assessment of that charge is \$364.47 calculated as follows:

TOTAL	\$364.47
Deduction of 5 hours decision-making time*	-\$100.00
Writing statement of reasons	\$65.50
Examining pages, redacting and scheduling documents	\$248.97
Decision-making time: \$20.00 per hour	
Search and retrieval time: 10 hours at \$15.00 per hour	\$150.00

^{*}The FOI Act provides that the first five hours of decision-making time are free of charge and this is reflected in the calculation.

I am advised that the Department has in its possession 66 documents with 284 pages relevant to your request.

Required action

If you would like the Department to continue processing your request, you must notify the Department in writing within 30 days of receiving this notice that you:

- agree to pay the charge;
- wish to contend that the charge has been wrongly assessed or should be reduced or not imposed or both; or

• withdraw your request.

If you do not provide a written response in accordance with one of the above options within 30 days of receiving this notification, your request will be taken to have been withdrawn under section 29(2) of the FOI Act.

Alternatively, you may wish to revise the scope of your request. If you would like to discuss this, please contact foi@dcceew.gov.au for assistance.

Option - pay the charge

As the charge exceeds \$100, you are required to pay a deposit of \$91.12. You may, of course, elect to pay the charge in full at this point.

If you are not able to pay by direct deposit, please contact the Department for assistance.

Option - seek reduction or non-imposition of the charge

You may contend that the charge has been wrongly assessed, or should be reduced or not imposed. Section 29(5) of the FOI Act provides that, in deciding whether to reduce or not to impose a charge, the decision-maker must take into account any relevant reasons, including whether payment of the charge, or part of it, would cause you financial hardship, and whether the giving of access to the documents is in the general public interest or in the interest of a substantial section of the public.

If you wish to contend that the charge has been wrongly assessed or should be reduced or not imposed, please set out your reasons and the evidence in support of your reasons as clearly as possible. If you believe that payment of the charge would cause you financial hardship, please provide sufficient details of your financial circumstances to enable the decision-maker to make a well-informed decision in this regard.

Option - withdraw your request

If you wish to withdraw your request you may do so in writing.

Time limits for processing your request

Section 31 of the FOI Act provides that where a notice is sent to an applicant regarding the payment of a charge in respect of a request, the time limit for processing the request is suspended from the date the notice is received until either:

- the day following payment of the charge (in full or the required deposit); or
- if applicable, the day following the notification to the applicant of a decision not to impose the charge.
